# Health Impact Project

---

A national initiative designed to promote the use of health impact assessments (HIAs) as a decision-support tool for policy makers.

# Health Impact Project

---

- Creating a center of excellence and providing the coordination and infrastructure needed to establish HIAs as a well-recognized field in the U.S.
- Building a training and technical assistance network that will support new and existing HIA practitioners and centers
- Completing two federal-level HIAs
- Researching and broadly disseminating a review of existing laws, regulations and policies that might support the use of HIAs and help practitioners find new opportunities to implement them.
- Funding a series of demonstration projects

# Health Impact Assessment

---

HIA uses a systematic process that draws on scientific data, a range of analytic methods, and stakeholder input to identify the potential health effects of a proposed policy, project or program, and to help craft policy recommendations that minimize risks and capitalize on opportunities to improve health.

# Health Impact Assessment...

- Informs an active decision-making process: proposed legislation, permitting a new project, etc.
- Adds the most value when it addresses a decision that would not otherwise have factored health in, and where health effects may not be obvious.
- Looks at health from a broad perspective that considers social, economic and environmental influences
- Has well-defined steps, but varies considerably in terms of analytical methods, length and cost.
- Actively engages stakeholders (affected communities, decision makers, project proponents) throughout the process.

# Steps of HIA

---

1. Screening
2. Scoping
3. Assessment
4. Recommendations
5. Reporting
6. Monitoring and Evaluation

# Call for Proposals – The Basics

---

- Up to eight demonstration projects
- \$25,000 - \$125,000 for each grant.
- Projects must be completed in 18 months.

# Am I Eligible to Apply?

---

## **Applicant organization must be. . .**

- A state, tribal or local agency; or
- A tax-exempt educational institution; or
- A charitable organization that is exempt from federal income tax.

## **In addition, applicant organization must. . .**

- Be located in the United States or its territories; and
- Address a proposed local, tribal or state policy, program or project in the United States or its territories or a federal decision process in which the effects are limited to a specific state, local community or region.

# Call for Proposals

---

- We encourage applications from organizations representing a range of fields and sectors.
  - public health organizations and agencies, or
  - applicants whose primary focus is not health
- HIA experience is not required.
- We will provide two types of training and technical assistance:
  - a specialized package of training and technical assistance in HIA.
  - consultation with experts in a specific subject area required for the analysis.

# What types of HIAs will we fund?

---

- HIAs that address a **proposed** project, policy or program on which a decision can be reasonably expected within 1-3 years. For example:
  - Legislation that is introduced and under debate, or will be introduced within a defined or predictable period of time.
  - A project that is being planned or has been proposed, and is undergoing some type of formal permitting or regulatory review.

# What types of HIAs will we not fund?

---

- We will not offer general programmatic funding.
- Proposals that address only a single health issue will generally not be considered: the HIA should address any important positive and adverse health effects associated with the decision.
- We are not accepting proposals that focus solely on clinical health care issues.
- Proposals focused on areas other than urban land use planning will receive preference.
- We will not consider proposals addressing transit-oriented development.

# Selection Criteria

---

- Stakeholder engagement, through partnerships, soliciting input, and responding to concerns of affected communities and key stakeholders
- Partnerships
- Strategy for effective dissemination and translating the findings and recommendations into policy change
- Importance to public health
- Adding new information that would not otherwise be considered in the decision-making process
- Commitment to an impartial, science-based appraisal of the risks, benefits trade-offs and alternatives.

# Current Health Impact Project Grantees

- A local health department will inform the planning and permitting process for proposed coal-gasification projects in Kentucky.
- An HIA in Chicago will address the health effects of a proposal by Commonwealth Edison to implement “smart metering” technology.
- A faith-based organization in St. Paul, Minnesota is undertaking an HIA of proposed land-use changes related to a new light rail transit line.
- A New Hampshire HIA will inform lawmakers on how funding changes in parts of the state budget might affect the health of residents.
- A nonprofit organization is looking at the possible health effects of proposed statewide “farm-to-school” legislation.
- A university is working with the Atlanta Regional Commission on a regional comprehensive plan.

# Application Process

---

There are two stages in the competitive proposal process:

**1. Brief proposal (due June 1, 2011)**


*(invitations for full proposal sent July 1, 2011)*

**2. Full proposal (due September 16, 2011)**

Notice of funding decisions will be sent December 2011.

### INSTRUCTIONS

#### Health Impact Project Online Application

Before beginning the online application, please carefully read the [call for proposals \(CFP\)](#).

These materials, along with additional information about the project and HIAs are available on the [Health Impact Project Web site](#). Many of your questions may be answered by reading the [Frequently Asked Questions](#).

As explained in the CFP, there are two stages in the competitive proposal process: (1) applicant organizations submit a brief proposal that describes the project and; *if invited*, (2) select applicant organizations will then submit a full proposal, budget, budget narrative and organizational documents for review. Although the full proposal application will only be available to invited applicants, you may want to review more information about the [full proposal](#) before submitting your brief proposal.

Please also note the following important information before submitting a brief proposal:

- All brief proposals must be submitted on or before June 1, 2011 to be considered for funding.
- Health Impact Project staff will notify all brief proposal applicants via e-mail whether or not they have been invited to submit a full proposal by July 1, 2011.
- The application will become part of the official record of your request and, if approved, the grant file.

# Online Application Tips

---

- Draft responses offline, to more easily edit and save your work. Then, copy and paste into the application response boxes.
- Use the “save” function in the system often! The system is unable to recover unsaved work. Then, proceed to the next tab or sub tab.
- The “preview” feature will allow you to view the questions and your responses on one page. You can save or print this for your records before submitting.

# Application Stage #1: Brief Proposal

---

- Letters of support can be submitted at this stage, but this is not required. These might come from potential partners, stakeholders, or decision makers.
- Applicants should estimate a project request that takes staffing and the grantee meeting into account.
- Partnerships are encouraged. One organization must serve as the recipient of the funds and will be the point of contact for grant reporting.
- Each applicant may submit up to two different brief proposals. We will ultimately fund one project per organization.

# Application Stage #2: Full Proposal

---

If invited, you will be asked to submit:

- A detailed project narrative
- A budget, budget narrative, supporting documents
  - At the full proposal stage, you will be required to consider a staffing plan in your budget. We estimate that applicants should budget a .5 FTE for one professional staff member to serve as the project coordinator.

# Grantee Requirements

---

- Regular meetings with technical assistance partners and project staff
- Completed HIA report
- Narrative and financial grant reporting
- Annual meeting
  - Applicants should include travel to this meeting in their project budget.
