Re: MoU with ICES and information on biomass levels of stocks

Brussels, 24 November 2015

Dear Mr. Aguiar Machado,

Thank you for the constructive meeting on 10 November. By way of follow up, can you confirm that in 2016, the Commission will seek advice from the International Council for the Exploration of the Sea (ICES) on the status of biomass in relation to levels capable of producing maximum sustainable yield (MSY)?

As you are aware, the reformed Common Fisheries Policy (CFP) sets the objective to restore and maintain populations of fish stocks above biomass levels capable of producing MSY. While no clear date has been set for achieving this objective, it is important to know which stocks are recovering and moving above biomass levels capable of producing MSY (i.e. B_{MSY}), and which stocks are already at or above that point. Without this information, it will not be possible to evaluate whether fisheries management is achieving the objectives of the CFP as defined in Article 2.2. Also, providing such information will build greater understanding of the state of stocks among scientists, stakeholders and policy-makers and will facilitate the monitoring of progress towards full implementation of the CFP.

This information has not been presented in the Commission's communications on fishing opportunities for 2015 and 2016². We were informed during recent exchanges with your services that the Commission might request further information from ICES about biomass levels. Given the importance of the information to evaluating progress of the CFP as well as the Marine Strategy Framework Directive, we would welcome confirmation that the

Commission will ask for specific advice from ICES in 2016 and beyond on the biomass levels of EU fish stocks in relation to the B_{MSY} reference point. In addition, we would like to request that your services publish any existing ICES information on the level of biomass of EU fish stocks in relation to the B_{MSY} reference point.
